Is there a trade-off between costs and quality in hospital care: evidence from Germany and the US

Providing high-quality health care services at reasonable costs is the central policy goal in most health care systems. However, only very few studies exist in health economics that investigated a possible trade-off between costs and quality of care. The key question is: does the quality of care remain the same if costs are reduced? The presentation reports results from a study that investigates and quantifies the relationship between hospital costs and the quality of care for patients with acute myocardial infarction in Germany and the US.

13:15 Professor Alistair McGuire, London School of Economics and Political Science Competition in health care: The UK evidence

This presentation will outline the evidence on recent changes in incentive structures within the UK National Health Service and their effect on outcomes. The discussion will focus on the introduction of patient choice and fixed payment schemes for hospitals, but will also cover the quality assessment framework in place for GPs, particularly as the new current reforms for the NHS are centred around GP purchasing of health care.
