International Network Programme (INP)

Call for proposals for [the International Network Programme](#) which aims at initiate new network activities with China, India, Israel, Japan, USA, Brazil, Turkey, South Africa and the Republic of Korea

The INP is aimed at giving researchers from both the public and the private sector an opportunity to establish networks and cooperation with researchers from countries that the Danish Agency for Science, Technology and Innovation has bilateral agreements with.

Grants are given to projects where there is not already a well-established connection between the project partners and for the following activities:

- Scientific workshops and conferences with participation of researchers, scientists, research experts and PhD-students from Denmark and from one or more of the selected countries.
- Travel between Denmark and the selected countries in order to identify potential for new projects and partnerships.

10 million DKK has been reserved for this call. Each application can only be supported up to max 200.000 DKK, excl. OH.

The Ministry of Food, Agriculture and Fisheries - GUDP

Innovation Fund Denmark - Industrial PhD projects

IFD calls for proposals for [Industrial PHD projects](#) An Industrial PhD is an industrially focused 3-year research project and PhD education, conducted jointly by a private sector company (or public institutions), an Industrial PhD candidate and a university. The Industrial PhD candidate is employed by the company and at the same time enrolled at the university. The candidate spends all her/his working time on the research project and PhD education, and divides the working time between the company and university. The company is the formal applicant. Please note that the Innovation Fund has opened this funding opportunity for public institutions for the round of applications with deadline on September 19, 2016.

The aim of Industrial PhD Program is:

- To educate researchers at a PhD level with knowledge about industrially focused research and innovation
- To create growth in the Danish business community by increased cooperation on research and innovation between universities and privately held companies
- To facilitate knowledge transfer and networking between Danish companies and researchers at universities in DK and abroad.

Griffith University, Australia, and the University of Southern Denmark have established a strategic cooperation with a focus on research and education. Researchers from each institution have the possibility to apply for seed money for joint projects such as research projects, papers or grant applications, etc.

Danish private funding:

The Velux Foundations – VILLUM Investigator

The aim of [the Villum Investigator Program](#) is to support researchers who have the potential to make significant contributions to technical and natural sciences.

It is expected that the VILLUM Investigators identify and pursue significant research questions and that they push their chosen research fields and/or methods into new areas of investigations.

Applicants to the VILLUM Investigator Programme are expected to be active researchers who have a track record of significant and excellent research achievements in the last 10 years.

The grant is for six years, after which period, grantees are permitted to reapply in competition with other applicants. The grant total is DKK 20-40 million, including start-up costs, and a proportion of the grant must be used for hiring a secretary, assistant or the like to relieve the researcher of administrative burdens. The research must be conducted at a Danish research institution.

Den Danske Maritime Fond

Call open for applications to [Den Danske Maritime Fond](#). The aim of the Fund is to provide financial support for initiatives and measures that can serve to develop and promote Danish shipping and / or Danish shipyard industry. There is no detailed criteria for the types of activities the Foundation wants to promote, but the Board like applications for activities that are innovative and business oriented and thus able to be commercialized.

Fabrikant Mads Clausens Fond

This is a general charitable foundation supporting the following:

- Purchasing of equipment for use in education and research (favorably in relation to Danfoss' products, production or employees)
- Stimulation of interest in science among children and young people

The foundation supports a project one time only, and the support is mainly given to projects that can make a difference for many people. The grants usually amounts to more than 25.000 DKK, however rarely more than 100.000 DKK.

The foundation does **not** support medical research, private individuals, travel and subsistence expenses, conferences (unless of special interest to Danfoss), salaries, small investments, and long-term research projects.

The foundation has an agreement with SDU that employees and students at SDU shall submit their application via Rektorsekretariatet at SDU. Applications must be sent to **Kirsten Fly Malling**, rektorsekretariatet, kfm@sdu.dk, who will coordinate and send them to Fabrikant Mads Clausens Fond.

The main research and innovation funders in the Nordic countries are now launching the joint [Nordic Green Growth Research and Innovation Programme](#) in cooperation with NordForsk, Nordic Innovation and Nordic Energy Research.

The programme will cover innovation, research and energy, as well as science and technology. The programme will generate Nordic added value and create synergies with relevant initiatives nationally and at the Nordic level. The programme encompasses two thematic areas relevant for both research and innovation. Overarching collaborative projects encompassing both research and innovation are encouraged under both thematic areas, with energy as a cross-cutting topic.

Relevant areas for research and innovation projects under thematic area I "Societal changes and future scenarios with focus on sustainable regional development" include:

- analyses of paradigm changes;
- new governance structures;
- institutional and public sector innovation;
- industrial transformations and development of conceptual frameworks to assist policymakers.

Relevant areas for the innovation and research projects under Thematic area II "Global competitiveness and catalysing investment and innovation in Nordic businesses to utilise the ongoing green shift" include:

- emerging technologies;

Research Fellowship

Sponsorship of scientists to conduct research projects in a different OECD member country with a view to strengthening the international exchange of ideas and increasing international mobility and co-operation. CPR supports transportation and subsistence costs to research scientists who should have 4 years of postdoctoral training, have a long-term renewable position, and are from member countries to conduct research in a laboratory in another Member country. Fellowships may be from 6 to 26 weeks.

Deadline: Fellowships to take place in 2017 must be applied for before **September 10, 2016**.

Conference Sponsorship

Sponsorship or co-sponsorship of international conferences, workshops, symposia, congresses, with a view to informing policy makers, industry and the academic world of current and future research, scientific developments and opportunities on issues relevant to the CRP and the OECD's policy priorities.

Eligible costs are expenses for invited speakers (travel and subsistence costs) for conferences to take place in 2017.

Deadline: 10. September, 2016

The Canon Foundation – research grants

The Canon Foundation in Europe offers research grants to highly qualified European and Japanese researchers who obtained at least their Master's degree within the last ten years. This is the minimum requirement. Non-nationals should have permanent citizenship in either Europe or Japan.

We welcome applications in all fields of research. Successful European applicants should carry out their research in Japan and Japanese must do their research in Europe.

Fellowships are awarded for minimum three months to maximum one year. Financial support for Fellows ranges between 22,500 to 27,500 Euros per year

Marie Skłodowska-Curie Individual Fellowships

The goal of MSCA-Individual Fellowships is to enhance the creative and innovative potential of experienced researchers, wishing to diversify their individual competence in terms of skill acquisition through advanced training, international and intersectoral mobility.

Individual Fellowships provide opportunities to acquire and transfer new knowledge and to work on research and innovation in a European context (EU Member States and Associated Countries) or outside Europe. The scheme particularly supports the return and reintegration of researchers from outside Europe who have previously worked here. It also develops or helps to restart the careers of individual researchers that show great potential, considering their experience.

The Fellowship is based on an application made jointly by the researcher and the beneficiary in the academic or non-academic sectors.

Deadline: 14 September 2016

LIFE

LIFE is the European Programme for the Environment and Climate Action.

The LIFE Programme is structured in two sub-programmes: the sub-programme for environment and the sub-programme for climate action.

The sub-programme for environment covers three priority areas:

- *LIFE Environment and Resource Efficiency*
- *LIFE Nature and Biodiversity*
- *LIFE Environmental Governance and Information*

The sub-programme for climate action covers three priority areas:

- *LIFE Climate Change Mitigation*
- *LIFE Climate Change Adaptation*
- *LIFE Climate Governance and Information*

The 2016 call opened in May with deadlines in September depending on sub-programme and priority area.

COST Actions – [Open call for proposals](#)

COST Actions are a flexible, fast and efficient networking instrument for researchers, engineers and scholars to cooperate and coordinate nationally funded research activities. COST Actions allow European researchers to jointly develop their own ideas in any science and technology field.

COST Actions are bottom-up science and technology networks, open to researchers and stakeholders with a duration of four years. They are active through a range of [networking tools](#), such as workshops, conferences, training schools and dissemination activities. COST does not fund research itself.

COST Actions are networks centered around nationally funded research projects in fields that are of interest to at least five COST countries. The financial support averages EUR 130 000 per year for a four-year period. COST prides in its support for high-risk, innovative and emerging research themes. However, COST does not set any research priorities.

You can submit your COST Action proposal at any time throughout the year. The next Collection Date is tentatively set for 1 December 2016, at 12:00 CET.
