**About the research Project:** My research project focuses on the study of the perspectives provided by Italian law n. 194/2015 on the *«Protection and enhancement of agricultural and food biodiversity»*, which has institutionalized the figure of *«guardian farmers and breeders»* and the *«Communities of Food and Biodiversity of Agricultural and Food Interest»*. The guardian farmers and breeders are defined «as farmers and breeders who are engaged in the conservation, within the farm or *in situ*, of genetic resources of food and agricultural interest local, plant or animal, subject to risk of extinction or genetic erosion». The Food and Biodiversity Communities of Agricultural and Food Interest are defined as *«local areas deriving from agreements between local farmers, farme* 

and custodial breeders, joint purchasing groups, schools, universities and research centers, associations for the protection the quality of biodiversity of agricultural and food interest, school canteens, hospitals, catering establishments, commercial establishments, small and medium-sized agricultural and food processing enterprises as well as public bodies». These new figures could be protagonists in the coming years of a new season of multifunctional agriculture and the project aims to frame within the methodological platform of Agroecology. The research aims to compare the Italian experience (with particular reference to the agricultural realty of Puglia and Salento) with the international ones to see how they can contribute to the revitalization of traditional rural systems. In this first step of my research route, my study activity mainly concerned the theoretical framework of the project and the reconstructing of European and Italian legal panorama concerning the protection of agro-biodiversity.
