Exemption / Special Permission

Check out the different types of exemption / special permission and more detailed information about the required documents you must attach to your application:

I do not fulfil the specific entry requirements (BA - §6 stk. 3 / PBA - § 9)

Documentation can be:

- Documentation you think can replace the requirement
- Documentation about the level of the course, the extent, the amount of hours and the course description

I do not have a qualifying examination, i.e. special permission (BA - §5 stk. 6 / PBA - § 9)

Documentation can be:

- CV
- Documentation stating that you can cover the specific entry requirements
- Documentation about the qualifications you think can replace the requirement of the qualifying examination (diplomas/certificates of former educations)
- Documentation about a considerable written task

I cannot cover the grade requirement of quota 1 or quota 2 (BA - §8 stk. 5 / PBA - § 8 stk. 5)

Documentation can be:

- Application for exemption stating the special circumstances and how those have affected the grades you have obtained
- Doctor's note or an excerpt of your medical record in case of long-term illness (both course and extent of the illness)
- Doctor's note or documentation about critical or terminal illness of immediate family
- Statement of a specialist, e.g. due to dyslexia, dyscalculia or functional impairment
- Statement of a psychologist or psychiatrist
- Police report
- Grade transcripts of your upper secondary education
- 9th / 10th form-level school-leaving examination (can be necessary if the special circumstances have been current already)
- Statement of a careers teacher/student counsellor, teacher or head of your former institution

Exemption / Special Permission

I have already finished a Master's degree - restrictions on double degrees (BA - §3 stk.2 /PBA - §3 stk.3)

Documentation can be:

- Documentation accounting for the special circumstances which cause the reason you are no longer able to work with your Master's degree
- Documentation about the special circumstances, e.g. doctor's note, medical record, statement of a psychologist or similar

I cannot cover the required GPA in quota 1 (BA - §15 stk.7 /PBA - §16 stk.7)

Documentation can be:

- Application for exemption stating the special circumstances and how those have affected the grades you have obtained
- Doctor's note or an excerpt of your medical record in case of long-term illness (both course and extent of the illness)
- Doctor's note or documentation about critical or terminal illness of immediate family
- Statement of a specialist, e.g. due to dyslexia, dyscalculia or functional impairment
- Statement of a psychologist or psychiatrist
- Police report
- Grade transcripts of your upper secondary education
- 9th / 10th form-level school-leaving examination (can be necessary if the special circumstances have been current already)
- Statement of a careers teacher/student counsellor, teacher or head of your former institution

NOTE! An application for exemption/special permission is <u>NOT</u> an application for admission You still need to apply for admission via Optagelse.dk. The application system opens on 1 February.

Application deadline for all types of exemption/special permission is 15 March, noon.

Application for admission via Optagelse.dk: Foreign qualifying examination - before 15 March, noon Danish qualifying examination – quota 2: before 15 March, noon / quota 1: before 5 July, noon

Pre-assessment

You can apply for a pre-assessment for your application for exemption/special permission in between 1 September – 1 December. Send the application to us by mail – optag@sdu.dk.

We aim to answer your request before 1 February. The facts and documents of your application for exemption/special circumstances must be assessed thoroughly. This is a time-consuming process and to make it work, you have to abide the given deadlines when sending required documentation to SDU. When we receive all needed documents in time, the Admission Office at SDU can finish the assessment of your application within the statutory time frame.

When you apply after 1 December, send your application for exemption/special permission along with your application for admission via the Danish National application system <u>www.optagelse.dk</u>. The system opens on 1 February and the application deadline is 15 March, noon.

Legal basis

All applications for exemptions/special permissions, no matter the kind, are processed according to the act about admission to full-time study programmes at Universities: Bachelor's programmes: no.35 of January 2022 / Professional Bachelor's programmes: no. 36 of January 2022.
